Ms. Pasch served as a Representative in the Wisconsin State Assembly. She used her health care expertise to advance health care laws, most notably, Mental Health Parity.

Ms. Pasch will fill the role of a Health Care member that resides in Milwaukee County on the COA. I look forward to her leadership on the Commission.
