## **REQUEST**

This Informational Report provides an update to the potential funding for a fence at Boerner Botanical Gardens. This report is a response to 2023 Budget Amendment #68.

#### **BACKGROUND**

In the 2023 budget, Amendment #68 approved by the County Board of Supervisors states the following –

"Amend the narrative of Agency 900 – Department of Parks, Recreation and Culture by adding the following language:

The lack of a perimeter fence at Boerner Botanical Gardens continues to be an issue for the park. A permanent perimeter fence is essential to protect garden plantings from deer grazing, potential vandalism, and ensure visitors pay the admission fee which supports the fiscal viability of the Boerner site. The Department of Parks, Recreation and Culture shall explore and recommend funding sources for the planning and design phase of a fence at Boerner Botanical Gardens. The department shall provide a report for the March 2023 County Board meeting cycle to report its findings."

Boerner Botanical Gardens is a formal garden within Whitnall Park that showcases plant collections and displays, as well as educational and event programming. The garden charges admissions for entry to experience the manicured garden setting, displays, and

## programming.

In years before 2020, the garden was unfenced and allowed individuals to enter at will, resulting in a loss of revenue collected. Since 2020, temporary snow fencing has remained in place to deter visitors from accessing the site without paying admissions.

Recently, the potential to fund the planning and design aspect of a more permanent fence was brought to the American Rescue Plan Act Taskforce, where it was considered, but did not receive approval.

Due to this consideration, and knowing that there is currently no funding available, this project will be incorporated into Parks capital project plan for funding consideration in the future.
