In December of 2021, US Surgeon General Vivek Murthy issued the Advisory on Protecting Youth Mental Health outlining the pandemic's unprecedented impacts on the mental health of America's youth and families, as well as the mental health challenges that existed long before the pandemic. Murthy called for a coordinated national response to this crisis. A topline recommendation of the report is to ensure that every child has access to high-quality, affordable, and culturally competent mental health care.

We have a long and successful track record of meeting the mental health needs of Milwaukee's County's youth. We operate a mental health clinic in our youth homeless shelter with licensed professional counselors working seven days a week to provide free individual, group, and family therapy to all residents in our shelter as well as any non-residents who are in need of this service.

We are seeking funding to partner with Milwaukee Christian Center to place a licensed professional counselor (LPC) in the afterschool program they operate at Kosciuszko Community Center. They serve young people ages 7-19 from 3-7pm, Monday through Friday. They also operate throughout the summer.

This would be year-round cultivation of relationships and care.

We are in a strong position to hire for this role. We have relationships with graduate level interns from universities throughout the region. We also work to provide compensation that reflects the advanced education that is required for the role as well as the high standard of care we expect our counselors to provide to young people.

This proposal aligns with the work done by the Milwaukee County Health & Human Services, Behavioral Health Division.

Goals of Walker's Point Youth and Family Center Counseling:

- Enhance the young person's understanding of self and their present situation
- Encourage good communication and decision-making skills
- Provide appropriate information and counseling in specific areas of concern (such as family communication problems, physical/sexual abuse, school related issues, alcohol and other drug abuse, sexuality and pregnancy issues, and dealing with trauma)

We look at several metrics to determine the success of our mental health treatment. Beyond looking at number of youth/young adults served annually, we also take into consideration both client and therapist assessment on progress made post-therapy. We track and report out on the following metrics:

- % of youth who felt better able to cope with the problems that caused them to seek services;
- % of youth who felt their relationship with their parent(s)/guardian(s) remained the same or improved;
- % of youth who felt better able to handle difficult feelings/negative emotions;
- % of youth who reported that they would return if problems were to persist in the future;
- % of youth who developed a new, or strengthened an existing supportive relationship with at least one caring adult.

Our past responses from clients have ranged 83%-93% in the metrics above.

This project aligns specifically within Milwaukee County's Invest in Equity objective. This project is an investment upstream to address health disparities particularly for BIPOC youth, and those with no insurance/resources to pay for therapy services, as well as dismantle barriers such as transportation to be as inclusive of a project as we possibly can be.

Our current practice provides services in shelter to young people who are staying with us as well as non-residents. Our clients are almost exclusively historically underserved, marginalized, and adversely affected groups.

We seek to achieve racial and health equity. According to the William T. Grant Foundation report, primary factors which contribute to and perpetuate mental health disparities among minority youth include: socioeconomic status, exposure to ACEs, neighborhood stress, family structure, practitioners' bias. 100% of the youth we serve live below the poverty line and almost all come from lower income neighborhoods experiencing stress. 80% of youth identified as ethnic and racial minorities. One-third of youth are LGBTQIA+. 50% of the youth we served come from non-traditional homes. Factors seeking services- 91% cited family conflict, 76% abuse, 53% mental health issues and 20% identified drug or alcohol abuse.

Breaking down barriers to treatment is a cornerstone of our service model. We do not bill insurance or seek payment for services. Any young person 14 and older can seek treatment, regardless of parent permission. This helps young people seek treatment in situations where there is family stigma regarding mental health issues. If transportation is an issue, we will provide bus passes or transportation stipends, as well as meet the youth and their families in the community. One of our therapists is bilingual and is able to provide services in Spanish.

This proposal would take our service outside of the shelter setting in order to provide counseling upstream in the community. The goal is to invest resources in the community to provide young people with a mental health toolkit that may negate a future need for shelter stay or more acute mental health care needs. This collaboration will provide increased visibility and strengthen community relationships for Walker's Point. This collaboration will build capacity for an already successful youth development program operated by Milwaukee Christian Center. The program does not offer mental health counseling at this site.

Kosciuszko Park is located in the Lincoln Village neighborhood. According to resident demographics from City-data.com, 67.9% are Hispanic or Latino, 9.7% are Asian, 9.3% are White, 7.3% are Black, 2.9% are two or more races, and 2.2% are American Indian. We believe providing this service in this neighborhood contributes to the County's pursuit of racial and health equity.

Solution Focused Brief Therapy The Therapist assesses the elements of the youth client's life that they want to change. The client and Therapist devise a vision of what the possible future could look like. The Therapist then helps the client to find specific moments in his or her life where they dealt with similar experiences in which there was a response that led to a successful outcome. <u>Crisis Intervention</u> Based on crisis theory, crisis intervention is time limited and goal directed. The Therapist identifies major problem(s), including what in their life has led to the crisis, and explores what strategies the youth has used to cope with the crisis. The Therapist helps the client understand what coping mechanisms have been problematic, what have been positive, and look to develop new coping strategies.

<u>Cognitive Behavioral Therapy (CBT) (including Trauma Focused CBT):</u> CBT concentrates on identifying erroneous thoughts and their associated feelings and behaviors. The Therapist helps youth to restructure these thoughts in order to positively change behaviors, and cope better with the negative feelings. In individual sessions, the Therapist may use CBT to address negative cognitions related to crisis, trauma and problems. Walker's Point Youth and Family Center has a 45-year history of administering Federal Runaway and Homeless Youth funds and meeting match requirements for these grants. Walker's Point pays an outside independent accountant to conduct the monthly bank reconciliations and to oversee our finances that we process in-house using QuickBooks. The Executive Assistant handles the internal bookkeeping, billing and management of the bank accounts. All Runaway and Teen Crisis Program disbursements are made in accordance to the project budget. Vouchers for project expenditures are first approved by the Executive Director or Director of Housing & Crisis Services, and then forwarded for check issuance. The Executive Assistant prepares the Agency checks, and each check must be signed by two other individuals, who have been formally approved in writing by the board of directors. The most recent audit letter reflects the unmodified opinion we have always received, and can be provided upon request.

A budget breakdown in the amount of \$190,975 is provided below. We have secured a \$50,000 grant from the Greater Milwaukee Foundation. Walker's Point is requesting \$140,975 that would cover the two year period starting 1/1/2023. We would expect to purchase supplies and equipment in the initial months of funding and incur ongoing personnel expenses on a monthly basis as the grant period expires.
