## **BACKGROUND**

Milwaukee County Parks frequently coordinates with WE Energies for the purpose of utility services both to Parks facilities and across parkland. The current request from WE Energies is to replace and relocate a gas main in the City of Milwaukee. Currently the gas main is located in the right-of-way of Hampton Avenue and it crosses the Lincoln Creek by way of a bridge attachment under the Hampton Avenue bridge. Relocation is required by the Wisconsin Department of Transportation due to the reconstruction/repaving of W Hampton Avenue between N Sherman Boulevard and N Teutonia Avenue. The proposed gas main would be installed by directional bore, which will require no disturbance of parkland for construction.

Parks has reviewed this request, and based on the size of the easement, the minimal impact to

parkland, natural areas, and recreational activities, and the overall benefit to the community as it relates to the improvements to Hampton Avenue, is recommending approval of this easement. WE Energies is offering \$1.28/square foot (\$55,756/acre) as compensation for the easement, which is more than the land values surrounding Parks property in this area, both commercial and residential, that range from \$20,000/acre to \$44,000/acre. The payment for the 0.0941 acre easement will be approximately \$5,248.

New services are installed by WE Energies and their contractors, and permission for installation work is granted through the Parks Right-of-Entry permit process. Granting the permanent easement is necessary for the long-term operation of the utility on Park property and requires authorization from the Milwaukee County Board of Supervisors and the County Executive.
