  - B. This action would increase Director's Office operating expenditures and revenues by \$225,000. A fund transfer related to this contract has been submitted for the April cycle.
  - C. This resolution would increase expenditures and revenues through 2025. Encumbered funds will be carried over through the life of the contract and grant funds will be drawn as needed to cover the expenses, so approval of this contract will have no net County fiscal impact. Existing staff time will be needed to implement these changes.
