MAJOR INITIATIVES

• 2022 – Electronic Patient Care Record Consolidation: Led the effort to consolidate 15 Fire/EMS agencies to a single platform. Focuses were efficiency of operations, expansion of technology and improved operations for data analytics and quality assurance to ensure the best possible patient care for our citizens.







- 2021 COVID-19 Vaccine Clinic: Organized and executed operations to provide more than 17,000 doses of vaccine to resident of Milwaukee County using EMS staffing exclusively. This was the second largest community clinic compared to the FEMA clinic. Also oversaw operation to provide more than 450 in-home vaccine doses.
- 2020 COVID-19 Dashboard: Provided direction and leadership to create and establish the <u>public facing dashboard</u> information relating to COVID-19 disease burden and vaccination activity within Milwaukee County. Special emphasis was placed upon race and ethnicity, one of the first in the country, to guide the response in an equitable manner. Multiple models were employed using the dashboard information to guide resources (SAFER Model and EVE Model). This dashboard was able to influence policy makers to increase access to vaccine sooner than others due to the data that my team displayed. This dashboard was recognized as a national model to advance equity.
- **2015 Patient Care Guideline Revision:** Revised the patient care guidelines protocol book for Bellevue Fire/EMS. Incorporated the latest scientifically supported evidence-based care as well as smart tools for ease of access and navigation for the EMS providers in the field.
