- A. The Harley Davidson Foundation (HDF) would provide grants to the Milwaukee Parks Foundation who would then grant funding to Milwaukee County to support 1) annual maintenance of the park and 2) capital investments for Highland Park in exchange for renaming it to Harley Park for a 10 year period.
- B. Annual maintenance would be supported by annual grants of \$10,000 totaling \$100,000 over a 10-year period. Funds will be distributed to Milwaukee County by the Milwaukee Parks Foundation and funded by the Harley Davidson Foundation. Capital improvements would be funded in three installments \$100,000 in year 1 (anticipated 2023), \$75,000 in year 2, and \$75,000 in year 3 for \$250,000 in total capital investment.
- C. Milwaukee County has not budgeted for either the increase in funds to the Operating nor Capital budgets. The capital investment would be received and spent on improvements annually. The ongoing maintenance contribution would benefit the Operating budget for each of the next 10 years.
