Request to amend the Milwaukee County Code of General Ordinances Chapter 69 Section 69.02 to add a 'No Parking' zone South 13<sup>th</sup> Street (CTHV) from 1300ft. South of W. Elm Rd. to 500ft North of W. Elm Rd., by recommending adoption of the following:

## A RESOLUTION/ORDINANCE

WHEREAS, Section 69.02 of the Milwaukee County Code of General Ordinances establishes parking regulations on Milwaukee County (the County) highways, pursuant to the authority established by Section 349.13, Wisconsin State Statutes; and

WHEREAS, the City of Oak Creek requested that the Transportation Services Division, Department of Transportation (DOT), review a concern of vehicles parking along South 13<sup>th</sup> Street (County Trunk Highway [CTH] V) from 1,300 feet South of West of Elm Road to 500 feet North of West Elm Road; and

WHEREAS, the Transportation Services Division-DOT has determined that there is a potential safety concern of vehicle sight distance, weaving, and lack of shoulder on South 13<sup>th</sup> Street CTH - V; and

WHEREAS, the Committee on Transportation and Transit (T&T), at its meeting of March 7, 2023, laid over File No. 23-353 for one meeting (vote 4-0); and

WHEREAS, T&T, at its meeting of April 11, 2023, recommended adoption of File No. 23-353 (vote 4-0), now, therefore

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 69.02 of the Milwaukee County Code of General Ordinances, by adopting the following:

## AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

**SECTION 1.** Section 69.02 of the Milwaukee County Code of General Ordinances is hereby amended as follows:

69.02. – Parking prohibited in designated areas.

No person shall stop or leave any vehicle standing in any of the following places, except temporarily, for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a licensed operator:

63	(a) Between the limits of North Port Washington Road and North Pierron
64	Road.
65	(4) South 68th Street (C.T.H. 'A')
66	(a) Between the limits of West Ryan Road and a point three-fourths (3/4) of
67	a mile north of Ryan Road.
68	(5) West Beloit Road (C.T.H. 'T')
69	(a) North side of the road from the intersection of South 108th Street
70	(S.T.H. 100) to a point five hundred seventy (570) feet east of South
71	108th Street.
72	(b) On both sides of the street from 100 feet east to 100 feet west of the
73	Root River Oak Leaf Trail Crosswalk east of West Howard Avenue.
74	6) West Layton Avenue (C.T.H. 'Y')
75	(a) From the limits of South 60th Street to a point eight hundred twenty-
76	five (825) feet east of South 60th Street.
77	(b) On the south side of the street from the limits of South 49th Street to
78	the limits of South 48th Street.
79	(7) South 92nd Street (C.T.H. 'N')
80	(a) On the west side of the street from the limits of West Howard Avenue
81	to the limits of West Waterford Avenue.
82	8) West Rawson Avenue (CTH 'BB')
83	(a) On both sides of the street from South 27 <sup>th</sup> Street to South Howell
84	Avenue.
85	(9) South 13th Street (C.T.H. 'V')
86	(b) On both sides of the street from 1300 feet South of West Elm
87	Road to 500 feet North of West Elm Road.

89	SECTION 2. The provisions of this Ordinance shall be effective upon passage and
