REQUEST

A report from the Director, Department of Health and Human Services, requesting approval to create 1.0 FTE Dementia Care Specialist in paygrade 29M and abolish 1.0 FTE ADRC Professional in pay grade 16Z4.

POLICY

BACKGROUND

The Dementia Care Specialist position is being requested for Aging and Disabilities Services within DHHS. Specifically, the Dementia Care Specialist will provide direct services to persons in communities of color with dementia and their families, train Aging and Disability Resource Center (ADRC) staff ongoing so that the ADRC is dementia capable, provide dementia training to ADRC vendors and other pivotal community service providers, expand the reach of the Dementia Care Services program by training volunteers, develop and implement programs to create and sustain dementia friendly communities, and develop referral protocols with dementia organizations in Wisconsin.
