Approval of this resolution will authorize the allocation of \$225,000 from Agency 194-1945 Appropriation for Contingencies to Capital Improvement Project WP080401 Repair of Old Loomis Road in support of immediate repairs to Old Loomis Road to help ensure safety for vehicles, pedestrians, pets, and users of the Oak Leaf Trail.
- B. The cost of the mill and overlay repair of the 0.4 mile portion of Old Loomis Road is estimated to cost \$225,000.
- C. The budgetary impact for 2023 increases the expenditures of Capital Improvement Project WP080401 Repair of Old Loomis Road by \$225,000 and decreases the expenditures in the Appropriations for Contingencies by the same amount. The current balance of the Unallocated Contingencies Account is \$X,XXX,XXX based on actions taken through the County Board meeting of April 20, 2023. Use of funds from the Appropriation for Contingencies either decreases the County's overall surplus at year's end or increases its deficit.
