AN AMENDED RESOLUTION

Reallocating the returned funds from the Friends of Hales Corners Park and Pool ice center-outdoor pavilion project to provide \$75,000 of financing to newly created Project WP077401 Hales Corners Park Walkway Replacement.

WHEREAS, the Friends of Hales Corners Park and Pool (FOHCPP) is a 501(c)(3) charitable corporation formed in 2003 with the initial mission to keep the Hales Corners pool open, but later expanded to include other development and improvement efforts within the park; and

WHEREAS, in 2015, the Friends of Hales Corners Park and Pool received a \$75,000 grant through the Milwaukee County Parks Amenities Matching Fund (PAMF) Program for the ice center- outdoor pavilion project; and

WHEREAS, the Department of Parks, Recreation and Culture entered into a Friends Agreement with the Friends of Hales Corners Park & Pool in 2019 (File No. 19-575); and

WHEREAS, despite the commitment of partial funding from the County and over a decade of fundraising, the FOHCPP has yet to establish a timeline to complete fundraising for the ice center-outdoor pavilion as recommended by the 2019 Milwaukee County audit of the Friends' Group (File No. 19-238), and now the project faces significant increases to the cost of construction; and

WHEREAS, all other PAMF funds awarded since 2015 have been expended for the benefit of Milwaukee County residents and considering the \$500 million of deferred maintenance projects Milwaukee County currently faces, it is the opinion of the Department of Parks, Recreation and Culture (DPRC) that these funds would be better used to fulfill other needs in county parks; and

WHEREAS, following a presentation and discussion at the January 2023 Audit Committee meeting, the Milwaukee County DPRC and Audit Committee have requested the Friends of Hales Corners Park and Pool return the \$75,000 grant, as it has been determined the funding would be better used to fulfill other needs in Milwaukee County parks; and

WHEREAS, at the January 2023 Audit Committee meeting the president of the Friends of Hales Corners Park and Pool verbally committed to returning returned the \$75,000 grant to the County as requested with in one month, roughly February 25, 2023; and

WHEREAS, though the future of the ice center-outdoor pavilion project remains uncertain, Hales Corners Park is in need of capital investment from the County to replace the walkways through the park that are in poor condition for maintenance projects such as replacing the wading pool concrete, playground PIP surface, and some of the current pathways; and,
