A. The Director, Department of Health and Human Services (DHHS) is requesting authorization to pay for essential pharmaceutical services, supplies, and medications provided to youth in the detention center. These services were rendered prior to a professional service agreement being signed and executed with Roeschen's Healthcare LLC (doing business as Omnicare of Milwaukee) and Children, Youth and Family Services (CYFS).

B. Approval of this request will allow DHHS to pay Omnicare approximately \$10,000 for these services starting January 1, 2023 to April 30, 2023.

C. There is no 2023 tax levy impact associated with approval of this request as funds sufficient to cover the cost of this contract is included in the 2023 DHHS Budget.

D. No assumptions were made.
