REQUEST

The Department of Information Management Services Division, Department of Administrative Services (DAS-IMSD) request the approval to create one (1) Analyst Security 1 position to support the IMSD Security Operations Center. DAS-IMSD also requests a transfer from the Department of Transportation, Airport Division to DAS-IMSD for actual costs in 2023. A direct service cross charge has been submitted as part of the 2024 budget request for this funding. If the transfer and position create is approved, DAS-IMSD and HR will work together to fill this position immediately.

BACKGROUND

The IMSD Security Operations Center has assigned an experienced Security Engineer to assess and design the architecture plan for integration with Milwaukee Mitchell International Airport (MMIA) and the plan for establishing an MMIA security program and plan, including an awareness program and training as needed post-integration.

The current Analyst Security position, which will become an Analyst Security II with no grade change, will be assuming some of the responsibilities of the Security Engineer, including the security awareness program and day-to-day security monitoring and operations activities. DAS-IMSD desires to recruit for an Analyst Security I. The new Analyst Security I position will be taking on the full responsibilities for daily operations.

The plan is to create the position in DAS-IMSD and receive the dedicated funding for the position through a monthly transfer of the actual amount from the Department of Transportation, Airport Division to DAS-IMSD for the remainder of the 2023 budget. A direct service cross charge has been submitted as part of the 2024 budget request to account for this position.

FISCAL EFFECT
