The annual cost of the position is \$84,947.20 - \$101,233.60. For 2023, the cost of the position will be funded by a transfer from the Department of Transportation, Airport Division to DAS-IMSD for actual costs. A direct service crosscharge has been submitted as part of the 2024 budget request for this funding. There is no tax levy impact.
