REQUEST

The Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute a renewal to a lease agreement with Goodwill Industries of Southeast Wisconsin, Inc. for Wil-O-Way Underwood Recreation Center.

POLICY

The DHHS Office for Persons with Disabilities (OPD) is requesting approval to enter a threeyear lease with two, one-year extension options with Goodwill Industries of Southeastern Wisconsin for the use of Wil-O-Way Underwood's main hall and office spaces. The lease is for an initial period beginning July 1, 2023.

BACKGROUND

Goodwill Industries has been leasing space at the Wil-O-Way Underwood since 2015 to provide a day service program called the Community Opportunities Club. The Community Opportunities Club supports adults who have a physical disability, brain injury, or mental health support need to regain the confidence and independence needed to lead more productive and active lives. Goodwill provides activities based on individual interests and needs. The participants may choose a variety of opportunities to improve life skills through vocational referrals, health and wellness activities, arts and enrichment classes, community integration and volunteer opportunities. The result of this selection of structured and self-directed activities is enriched lives and lifelong friendships. DHHS received lease renewal approval from the County Facilities Planning Steering Committee on April 20, 2023.

ALIGNMENT TO STRATEGIC PLAN

By executing this lease and continuing our partnership with Goodwill at the Wil-O-Way Center, DHHS is supporting the County strategic area of investing in equity through enhancing the quality of life for people in the county, particularly those living or identifying with disabilities, while also increasing our fiscal health through earned income. This partnership will also dismantle barriers to diverse and inclusive communities and supports our vision of being the healthiest county in Wisconsin.

FISCAL EFFECT

This lease will provide OPD with an opportunity to continue its mission, per Chapter 73 of the Milwaukee County Code of General Ordinances, while also contributing to the County's earned income. The mission is to promote independence in persons with disabilities.

RECOMMENDATION

The Director, Department of Health and Human Services, recommends the Milwaukee County Board of Supervisors authorize a lease renewal to Goodwill Industries of Southeast Wisconsin, Inc. for the Wil-O-Way Underwood Recreation Center. The lease would be effective retroactive to July 1, 2023 and extend thru June 30, 2028 assuming two, one-year extension options are invoked.
