

Overall Sentiment







Dear Audit Committee/County Supervisors: First of all, thank you for your service to the residents of Milwaukee County. My name is Elaine Unger and I serve as a Village Trustee in the Village of Greendale, Wisconsin. The following comments are my own and not on behalf of the Village of Greendale or the Greendale Village Board.

As an elected official in Greendale, I represent and serve all of the Village's residents which has a population of approximately 14,600. The noise pollution coming from The Rock in Franklin, Wisconsin, which borders the Village of Greendale, has negatively impacted the quality of life of some Greendale residents living in the neighborhoods around the facility, in particular Neighborhoods A and B shown in Figure 2 of the May 2023 Rock Sports Complex Sound Study. And what matters to some Greendale residents, matters to me as an elected official.

I feel it's important to protect citizens and improve their quality of life which is why I have commented (via email and in person) at previous County Board and City of Franklin meetings expressing concerns regarding chronic noise intrusion into Greendale neighborhoods from the development. I myself have attended various events at The Rock. It's a great facility that brings visitors to both Franklin and Greendale.

However, as the Sound Study confirms, chronic noise intrusion does indeed affect Greendale residents, so I would ask that the County Board and County Staff take action to help mitigate the noise by: (1) requiring the repositioning of the facility's speakers away from residential neighborhoods; (2) requiring dependable, independent sound monitoring, and (3) establishing or advocating for a safe 50 decibel limit at the property line.





File 19-591 which is an audit of contracts between the County and outside parties. Concludes "more attention to details of contracts required" and that 2006 there is a "Failure to obtain County Board approval for agreements" So these issues that are prevalent in the Rock audit have been plaquing the County contract compliance since 2006. Why should citizens have quality of life infringed upon for hundreds of days a year because of incompetence at the County? County contracts have been an ongoing issue with diligence, management or even monitoring of contracts. This issue extends back to 2006 as indicated in former audit reports. The noncompliance issues of noise mitigation, TBE requirements and other issues could have been avoided if contracts were properly managed. The issues with contract compliance started in 2012 with the Rock. This "Rock Audit" is not a comprehensive audit. It neglects to fully research the compliance with noise mitigation including the very specific Noise Abatement Boundary Line that the noise is "clearly audible 2 miles" across this boundary. As indicated by citizens at public meetings and complaints for years. The RSG sound study report confirms that noise is clearly audible 2 miles away, which has been going on for years past the Development Agreement Noise Abatement Boundary which was established to protect citizens and the 7 parks within 2 miles from this noise nuisance. ASD highlights indicate "a cultural change is needed to eliminate lack of ownership of contract monitoring." The Rock Audit purpose was to assess compliance with the agreements which discovered the required noise monitors were not functioning properly since 2020 and what did the County do about it? Years later it is reported monitors are not calibrated, functioning for years. These 3 monitors for 140 acre piece of land bought for \$1 was the "mitigation plan" for the County. A monitor is not mitigation. It measures the mitigation, which there has been zero mitigation of noise in 10 years. The County established 79 decibels for this project with no authority to do so through the "negotiations" with the Rock. To establish this extraordinary standard that needs to be continuous for 30 minutes at the property line to homes. 79 decibels, same as standing 50' from a freight train and then doing it for 30 continuous minutes to be a "material violation" as defined by the County. The Corporation Counsel stated at County Board 9/28/17 in reponse to Supervisors Cullen and Alexander about concerns for ongoing noise: Maggie Daun "In the spirit of the agreements in here, I would argue, would permit the County to actually sue the operator" so who how did the author of this Audit Report for the Rock declare in the title "Unresolved Community Concerns beyond the County's ability to Solve" How was that determined when Corporation Counsel stated action could be taken several times during the County Board 9/28/17 meeting. That is the consistent pattern with this development. No accountability. No transparency. No good faith efforts to have a comprehensive, objective report (this report took 2 years to complete and does not mention the Noise Abatement Boundary line which is page 5 of the County Exhibit C. Very concerning. The audit was for all aspects of the

agreements. Citizens asked for the audit to extend to 2012 because of the compliance issues extending back the start of this partnership with the County.

The memorandum at the link above provides a preliminary analysis of the report and exhibits provided to the County Board by the Milwaukee County Sheriff's Office (MCSO) contained in File 23-834. It considers the extent to which the report responds to the Board's six (6) main requests contained in Resolution File 23-554. While there is evidence of some responsiveness here, my analysis reveals several important gaps between what the Board requested and what MCSO delivered. A summary of the most important gaps is as follows.

• Resolution Item 2 (compilation of reports): Where Item 2 is concerned, the report treats the request for a "compilation of reports" as a request for a list of reports.

• Resolution Item 3 (research plan on policies, procedures, and practices): The report does not provide information on best-in-industry procedures/policies; discussion of current procedures/policies is also limited.

• Resolution Item 6 (research plan for assessing overall health needs and risks of persons): The report makes no reference to this resolution item whatsoever.

Considering recent developments at the Milwaukee County Criminal Justice Facility (CJF), these gaps in the report merit serious scrutiny.
