This would help employees who do not have access to adequate paid sick time to cover the length of their absence. The funds shall be held in an allocated contingency account within this capital project pending a report from the Milwaukee County Department of Transportation (MCDOT) and Milwaukee County Transit System (MCTS) on the ability to procure electric busses to replace fossil fuel busses.
