BACKGROUND

During budget deliberations for the 2023 budget, amendment number 63 was adopted at the Finance Committee on Thursday, October 27, 2022. The amendment added the following to the budget narrative:

Funding within the CAMPAC program area includes \$13,000 for the Concerts in the Parks series. In 2023, the \$13,000 Concerts in the Parks earmark may be used to effectuate other programs within the parks, including community events, food truck festivals, seasonal activities, cultural events, and marketing for parks programming. The Department on Parks, Recreation, and Culture shall provide a report to the Board detailing how the funds were disbursed in advance of the September 2023 meeting cycle.

Milwaukee County Parks has been administering the Fund for the Arts since 2020. As such, the contract for the consultant in the annual amount of \$13,000 was cancelled and Parks was authorized to expend this funding for Concerts in the Parks. Through additional budget amendments requesting a review of the funding formula and the appointment of additional members of the Cultural, Artistic, Musical Programming Advisory Council (CAMPAC), the allocation method for the funding grants has changed. Milwaukee County Parks has not allocated for itself an amount of \$13,000 since 2020. After 2020, Parks has considered itself as other applicants and adhered to the results of the funding allocation. Parks received allocations of \$10,125 in 2023, \$8,352 in 2022 & \$10,426 in 2021.

Since 2021 Parks has utilized the funding appropriated through CAMPAC to support concert series in Boerner Botanical Gardens and Washington Park. Each series is supported primarily through private contributions. Parks has engaged with the promoters of each series to place the county contribution on an annually decreasing amount with a goal to fully remove support by Milwaukee County.
