At the time this report is being submitted, the Youth Commission has selected five applicants to represent the 1st, 5th, 6th, 10th, and 13th Districts on the Milwaukee County Youth Commission in 2024 and is seeking confirmation of these applicants by the Board of Supervisors:

There was extensive recruitment for the open districts from September 1-29, 2023, through schools; community organizations; County Board Supervisors (who posted in newsletters, etc.); the Milwaukee County website; social media posts by the Youth

Commission, County Executive Crowley, and Chairwoman Nicholson; a media advisory announcement; and a press conference held by the Youth Commission.

We received 32 applications for the nine open districts in 2024. Three districts had five or more applications (6th, 10th, and 13th); three districts had no eligible applicants due to residency verification (3rd, 11th, and 17th) and one district had no applicants (8th). Of the remaining applications, eleven (34%) were for the wrong district, seven (22%) of which were for seats that are not open in 2024.

We developed a plan for targeted recruitment in the districts that will have vacancies as of January 1, 2024, with a goal to have all seats filled and confirmed by March 31, 2024. In addition, we changed the recruitment and application timeline to open in May of the previous year for the following year to allow for increased awareness and applications.

County Executive David Crowley has appointed Loren Muwonge to represent him as his Co-Chair representative in 2024. Loren has served as the Youth Commissioner representing the 2nd District since January of 2023. She will succeed current Co-Chair Aaron Lee, who is a senior and will be graduating in May of 2024.

Since its last report to the Board of Supervisors, the Youth Commission has taken the following actions:

- Identified its priority areas to include:
 - Ending gun violence
 - Ending youth homelessness
 - o Improving youth civic participation/voting, and
 - o Increasing access to mental wellness.
- Created a plan for the \$50,000 appropriation for program-related funds in the CEX's proposed 2024 budget;
- Formed ad hoc committees to develop action plans for its two standing committees;
- Filled a vacancy by confirming a Youth Commissioner to represent the 16th District:
- Endorsed the Milwaukee County Climate Action 2050 Plan;
- Added a Facebook social media page to reach a wider audience;
- Held its first press conference; and
- Drafted its 2023 Annual Report (available on January 1, 2024).

The following offices/departments have presented to the Youth Commission since the last report: Office of Corporation Counsel (September), Office of Equity, Office of Sustainability, and Milwaukee Department of Transportation (October). The Department of Health & Human Services (DHHS) is scheduled to present to the Commission in November.

The Youth Commission is seeking a fifth volunteer Adult Advisor; the application is available on the Youth Commission website and is open until January 31, 2024.

In addition to their regular meetings, the Commissioners have participated in the following events, not previously noted:

- 414 Trust Youth Kickball Tournament on August 17
- 2024 Milwaukee County Budget Public Hearing on October 30
- Sherman Park Harvest Fest on October 28.

Upcoming events include:

- Nature hike and s'mores in Grant Park in November
- Two volunteer events during the holidays in November and December (TBD)
- Team building/retreat at the South Shore Pavilion on April 20, 2024

Members of the Milwaukee County Board of Supervisors are invited to attend the last meeting of the 2023 term on December 20, 2023, which will include a completion ceremony, and the first meeting of the 2024 term on January 24, 2024, which will include a reception and swearing-in ceremony.
