Approval of this resolution would reallocate American Rescue Plan Act (ARPA) funding totaling \$1,613,900 from 1AR43 - Reducing Medical Debt project to two other existing ARPA projects administered by DHHS: 1AR02 - Flexible Housing Subsidy Pool project and 1AR05 - Credible Messenger Program project.
- B. This action would decrease the Reducing Medical Debt ARPA funding from \$1,613,900 to \$0. ARPA funds to 1AR02 - Flexible Housing Subsidy Pool would increase by \$613,900, from \$1,500,000 to \$2,113,900, and funding to 1AR05 Credible Messenger Program would increase by \$1 million, from \$1,201,200 to \$2,201,200.
- C. The net fiscal effect of the reallocation is \$0.
- D. Costs are anticipated to be effective in 2023 and may carry forward until 2026 based on ARPA timeline requirements. Payments associated with these projects are anticipated to be made by or before December 31, 2026.
