# **Milwaukee County Departments/Division Participation Summary for January 2023**

### **KEY FINDINGS**

For the reporting period of January 2023, total contract dollars awarded was approximately \$75,814,669

Of that amount, \$8,261,954 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$6,031,051 or 72.9% of eligible contract dollars and 7.95% of total contract dollars awarded.

# Milwaukee County Departments/Division Participation Summary for February 2023

## **KEY FINDINGS**

For the reporting period of February 2023, total contract dollars awarded was approximately \$19,479,173

Of that amount, \$3,928,303 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$2,859,947 or 72.8% of eligible contract dollars and 14.685% of total contract dollars awarded.

# **Milwaukee County Departments/Division Participation Summary for March 2023**

For the reporting period of March 2023, total contract dollars awarded was approximately \$13,836,044

Of that amount, \$6,977,101 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$1,643,128 or 23.55% of eligible contract dollars and 11.87% of total contract dollars awarded.
