 - A. Approval of this contract will authorize the Superintendent of the Community Reintegration Center (CRC) to enter into a six-month Purchase of Service contract extension with Aramark Correctional Services, LLC.
 - B. Total cost for the contract is variable depending on the number of clients housed at the at the Community Reintegration Center, the Criminal Justice Facility, and the Vel Phillips Youth Detention Center and is estimated at this time to total about \$2,600,000 during the six month period. This increase includes an estimated inflationary increase.
 - C. Approval of this resolution has no budgetary impact the 2023 budget, sufficient funds are available in the 2024 Adopted Budget.
 - D. It is that the average daily population (ADP) will be consistant with the ADP from 2022.
