Request authorization to enter, amend and extend an Amendment 2 to the intergovernmental cooperation agreement with Racine County from January 1, 2024, to December 31, 2024, pursuant to Wis. Stat. §§ 66.0301 and 302.44 for the temporary housing of certain jail occupants, by recommending adoption of the following:

A RESOLUTION

WHEREAS, Milwaukee County (the County), as represented by its Director, Detention Operations Commander, Milwaukee County Jail (the Jail), has a need to transfer occupants of the Jail (each, a Transferee), to an alternate facility to open up space within the Jail for population management purposes; and

WHEREAS, Sections 66.0301 and 302.44, Wisconsin State Statutes, permit the County and Racine County (Racine) to enter into agreements for the cooperative establishment and use of jails for the detention and imprisonment of the Transferees before, during, and after trial, and for apportioning expenses; and

WHEREAS, the County and Racine entered into an Intergovernmental Cooperation Agreement (ICA) for temporary housing of certain Jail occupants starting in July 2022, and ending December 31, 2022; and

WHEREAS, the daily rate charged by Racine is \$70 (the Daily Fee) for each Transferee housed at the Racine Jail, including partial days; and

WHEREAS, Daily Fees and any other costs owed by the County hereunder will be invoiced to the County on a monthly basis, and will be due within 30 days after receipt of such invoice, and any documentation reasonably necessary for the County to validate the charges; and

WHEREAS, Amendment One to the ICA extends the agreement from January 1, 2023, to December 31, 2023; and

WHEREAS, Amendment Two to the ICA extends the agreement from January 1, 2024, to December 31, 2024; and

WHEREAS, the Committee on Finance, at its meeting of December 14, 2023, recommended adoption of File No. 23-933 (vote 4-1); now, therefore,

44 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
45 authorizes the Chief Deputy, Office of the Sheriff, to enter, amend, and extend
46 the proposed Amendment Two to the Intergovernmental Cooperation Agreement
47 with Racine County for the temporary housing of certain Milwaukee County Jail
48 occupants for the period of January 1, 2024, through December 31, 2024.
