- CMS Log: This week was reflective of training new officers who are still learning entries to CMS/RMS and procedures for Inspections. Officers are showing improvement in documenting begin/end times for inspections as well as documented observations. Consistency is what is lacking. There will be a short period of mentoring, before referring for discipline with new officers, unless they are purposely failing to follow guidance/orders.
- Pod Video: All pod video reflective of CMS Log and Schlage audit.
 Additional Notes:

- 1. Officers have been showing improvement in procedural concepts of performing Occupant Safety Checks/Inspections. Again, consistency is lacking with new officers. Once final policy is out in Lexipol, consistency may gain some traction.
- 2. Still waiting for updated policy to post to LEXIPOL.

Corrective Actions: No corrective for this period. Discussions and mentoring only to build upon compliance with inspection procedures, especially with new staff.

Roll Call Briefings: Reviewing procedures with second shift staff.

Mentoring:

Mentoring that has taken place with new officers. Check-ins also conducted after mentoring sessions.

Check-ins with floor control and assigned officers to discuss procedural matters and give brief on what is working/ what is not and how to resolve (through verbal or demonstrative means).

SUBJECT: Schlage Report- POD 4C July 26, 2023, 1400-2200 hours

1400- On Duty

Officers assigned by shift and number of rounds completed per Transactions Door Report-Schlage Report

2nd shift: Howard, Brionna 09

O'Neal, Angel 07 Proeber, Joel 18 Total: 34

Second shift inspection requirement for this housing unit is **32** rounds (16 upper/16 lower) from 1400-2200.

<u>Transaction Doors Report Audit Review:</u>

- Upper tier: 2nd shift inspections was 17 of 16 required = 106%
- Lower tier: 2nd shift inspections was 17 of 16 required = 106%
- Total complete is 34 of 32 = 106%
- All inspection rounds completed were 45 minutes apart or less

CMS Log Review:

- 17 of the (34) 17/17 total inspection rounds documented (CMS). It should be noted that CMS logs do not reflect upper and lower tiers. The log reflects a single round for the entire POD whereas, the Schlage report distinguishes between the main level and the Mezz level. Schlage report total is 34 (17/17).
- Documentation: Documentation is inconsistent with what has been covered at rollcall (begin/completed/observations). This is also likely to mid-shifters not receiving information going out at roll calls concerning inspections. Also seeing inconsistencies due day shifters not receiving same info as 2nd and third shift when conducting OT on these shifts.

Pod Video Review:

Pod video review shows quality of inspections for this date are adequate but still need improvement from newer officers.

MCJ Daily Brief Review:

Daily brief incidents did not play a factor for this housing unit as it pertains to inspections being completed on time.

Referral Recommendations: None for this date.

<u>Follow-Up</u>- Roll Call training on CMS/RMS entries, covered Schlage report and presented the report to staff at roll call. Reminder of procedural process.

Continue mentoring and coaching.
