REQUEST

At the time this report is being submitted, the Youth Commission has selected two candidates to represent the 2nd and 11th Districts on the Milwaukee County Youth Commission in 2024 and is seeking confirmation of these candidates by the Board of Supervisors:

District	Selected Candidate	Term
2	Marianna Taylor	January 2, 2024 (prorated)- January 1, 2026
11	Genevieve Skibicki	January 2, 2024 (prorated)- January 1, 2025

We are continuing to recruit to fill the three remaining vacancies in Districts 3, 8, and 17 as soon as possible. Recruitment for the 2025 term will begin three months earlier than previous years, in May of 2024, and the application period will open in August to increase awareness and applications.

Since its last report to the Board of Supervisors, the Youth Commission has taken the following actions:

- Volunteered at Breakfast with Santa at the King Center and Hunger Task Force in December of 2023;
- Held its completion and swearing in ceremonies in December of 2023 and January of 2024, respectively;
- Participated in the 2024 Wisconsin Counties Association (WCA) Legislative Conference with Chairwoman Nicholson and Supervisors Martin and Johnson,

and met with Governor Evers, County Executive Crowley, and Milwaukee Area Legislators at the State Capitol on February 7, 2024;

- Developed action plans for both standing committees; and
- Respectfully requested two changes to the Milwaukee County General Ordinances (through Adult Advisor Sup. Vincent);
 - Eliminate requirement that the Board of Supervisors must confirm new Youth Commissioners to reduce delays for onboarding new Commissioners (especially for vacancies in current terms); and
 - Add an at-large seat to the Youth Commission for an individual who is age 14-18 and actively attending high school but is experiencing housing insecurity and cannot apply to serve in a specific district.

County Executive Crowley appointed Byron Marshall and Chairwoman Nicholson reappointed Supervisor Kathleen Vincent as Adult Advisors for the 2024 term. The Youth Commission is seeking a fifth volunteer Adult Advisor; the application is available on the Youth Commission website.
