**POLICY**

**BACKGROUND**

The Christensen Consent Decree (Consent Decree) requires the County to engage a third-party medical monitor to review and report on healthcare operations at the Milwaukee County Jail and Community Reintegration Center. The Consent Decree further requires that the County's legal counsel and legal counsel for the plaintiffs in the Christensen Consent Decree litigation agree on the medical monitor vendor and ultimately court approval.

On September 21, 2018, the CRC (then the House of Correction), and the Office of the Sheriff issued RFP #98180023 "Correctional Medical Services Contract Monitor." The responses were due on October 26, 2018, and following evaluation by an Evaluation Committee comprised of medical, legal, risk, and fiscal professionals, the Evaluation Committee recommended award of the RFP to NCCHC Resources, Inc. The contract was awarded for a period of one year with 4 optional one-year renewals (the "Contract").

The Contract is set to expire on March 31, 2024. The Office of Corporation Council (OCC) and outside counsel for the County in the Christensen case advised that due to the requirements of the Consent Decree, it would be in the best interests of the County for NCCHC Resources, Inc. to continue to provide the healthcare monitoring services required by the court in which the Christensen case is pending. A request was made to review current monitoring needs and consolidate services where possible and to extend the current contract for an additional year, with two one-year extension options. Through the help of OCC, the County was able to very quickly negotiate an extension at a small

reduction in price.

This is a proposal to extend the contract with NCCHC Resources, Inc. to provide the referenced medical monitoring services.

As of the date of this writing the contract is still being written by DAS-Procurement, but the proposal is attached with this file.

**RECOMMENDATION**

The Superintendent of the Community Reintegration Center respectfully submits this action item to request the authority to enter into a one-year contract extension with two one-year extensions with NCCHC Resources, Inc to provide medical monitoring for the CRC and the CJF as required by the Consent Decree.
