Action report from the Office of Strategy, Budget, & Performance (SBP) Project Management Office (PMO) presenting the individuals selected by the Milwaukee County Youth Commission to represent the 2nd and 11th Districts in 2024, as well as an update about the activities of the Youth Commission, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the Milwaukee County (the County) Commission on Youth (Youth Commission) was created in 2002 to serve as a representative body for youth in the County; and

WHEREAS, the Milwaukee County Board of Supervisors, at its meeting of May 26, 2022, unanimously recommended adoption of File No. 22-662 (vote 18-0), to re-establish the Youth Commission; and

WHEREAS, the re-established Youth Commission held its initial meeting on January 25, 2023, and has met every consecutive month since that time (except during the August recess); and

WHEREAS, per adopted File No. 22-662: “Once seated, the commission on youth will appoint from within its ranks a selection committee of not less than five (5) commissioners. The selection committee will determine when applications may be submitted, conduct application reviews, interview candidates, and submit names to the county board of supervisors for confirmation;” and

WHEREAS, the Youth Commission designated its Committee on Governance, Finance, and Evaluation (GFE) as the Selection Committee under adopted File No. 22-662, and empowered the Commission Co-Chairpersons (the Co-Chairpersons) to make decisions regarding the selection process between meetings; and

WHEREAS, the Co-Chairpersons re-assigned the scoring to the Leadership Committee, which consists of the two Co-Chairpersons, and the Chairpersons and Vice Chairpersons of both standing committees, for the 2024 applicants; and

WHEREAS, because the Youth Commissioners serve staggered terms, approximately nine seats are open each year (subject to the ages of the selected candidates remaining 14-18 during their respective terms); and

WHEREAS, the selected candidates (top ranked applicant in each open district) appeared before the GFE on February 7, 2024, and received unanimous approval; and

WHEREAS, the Youth Commission has approved the selection of the following candidates to represent the districts indicated herein for the term lengths noted; and
