- A. Authorization to grant a 10-year easement to Midwest Fiber to install, operate, and maintain a fiber optic conduit line with the interest of providing wireless cellular service to the St. Johns on the Lake.
 - B. Direct Costs include existing staff time for review of legal documents and occasional supervision and inspection of the project. There will be an annual rent for the easement which is \$129.16 in 2024 and escalates annually by 3% for the life of the term. The full year rent price has a base of \$310. First year revenue will be \$1,629 accounting for the easement rent and the Right of Entry application. Parks has determined that this is a fair compensation for the temporary easement.
 - C. The revenue for the easement will be evenly divided into the playground and trails trust.
 - D. Easement dimensions are estimates and final recorded documents will be based on actual as-builts and will not exceed approved acreage. The current year budget costs are an estimate based off the completion date of 8/1/24.
