- A. Approval of this resolution/ordinance would amend the Milwaukee County Code of General Ordinances to increase the penalty for illegal dumping on County property from \$200 per day to a flat rate of \$5,000. Illegal dumping has been a growing issue for the County, and increasing the civil penalty for a violation is one strategy being implemented by the department to deter the illegal activity. \$5,000 is aligned with the penalty imposed by the City of Milwaukee for illegal dumping occurring on city property.
 - B. There are no direct costs associated with this resolution. Increasing the civil penalty is not projected to have a meaningful impact on revenue due to the relatively low number of citations issued annually and the high cost of clean up.
 - C. Approval of this resolution has no budgetary impact.
 - D. It is assumed increasing the penalty for illegal dumping will not have a significant impact on revenue, due to the relatively few citations that are issued annually and the high cost of cleanup which is currently absorbed by the department's operating budget.
