III. ANNOUNCEMENTS AND ADVOCACY OPPORTUNITIES

V. LEGISLATIVE AND POLICE UPDATES

A. Federal Aging Policy

I. Federal Budget and Issues

a. FY2025 Budget Update: The current 2024 Fiscal Federal budget ended on September 30, 2024. Due to the November elections and the uncertainty surrounding them, the 2025 fiscal federal budget is under a continuing resolution. Therefore, all the budget levels are set at the 2024 funding levels. After the elections, funding negotiations will continue to set the final 2025 Fiscal Federal Budget.

II. Federal Regulations and Executive Orders

a. U.S. Access Board Proposed Rule on ADA Compliance of Electric Vehicle Charging Stations – Comments due November 4, 2024: The US Access Board has proposed accessibility standards for electric vehicle charging stations. New funding has been provided to increase the number of charging stations throughout the US, including a significant number in Milwaukee County, which will impact the populations that Milwaukee County serves. Today, the Advocacy Committee is reviewing the current accessibility standards to identify any missing standard items in the guidelines. If any items need to be included, the Advocacy Committee will then draft a comment letter to the US Access Board. This letter will include the items they believe should be added to the current guidelines, along with a detailed explanation of why these items are important.

MOTION: To approve sending a comment on the U.S. Access Board Proposed Rule on ADA Compliance of Electric Vehicle Charging Stations.
