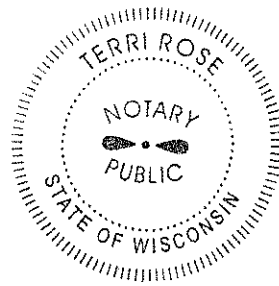

A portion of the proceeds from the sale of the Bonds will be loaned to Aero Milwaukee, LLC and used to refund certain outstanding indebtedness previously incurred for the following project (the "Project"), which Project is owned by Milwaukee County:
