From the Director of Department of Family Care to execute a professional Services Contract with Andrea & Orendorff, SC to provide Senior Management Services to the Department of Family Care – Managed Care Organization (MCO) under Family Care from January 1, 2013 through December 31, 2013, and a requirement that vendor service fees shall not exceed \$932,000 during the contract period and with the option of up to two one-year extensions without a competitive Request for Proposals (RFP) based on satisfactory vendor performance, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Wisconsin Department of Health Services (DHS) engaged in a comprehensive effort to redesign Wisconsin's Long-Term Support Services for older adults and persons with disabilities through the Family Care Program; and

WHEREAS, the purpose of Family Care is to divert persons requiring long-term care from expensive publicly funded nursing homes to more appropriate community-based forms of care desired by the clients themselves; and

WHEREAS, the Milwaukee County Board of Supervisors has authorized the Department of Family Care to participate as a Managed Care Organization under Family Care; and

 WHEREAS, in 2012, the Department of Family Care (MCO) issues a publicly solicited Request for Proposals (RFP) seeking a Fiscal Management Partner for assistance with the fiscal and business operations as a MCO under Family Care, as required by DHS and whose business objectives are aligned with the Department's vision for a Family Care MCO; and

WHEREAS, the new Professional Services Contract for Senior Management Services (1) remains quality and outcome based, (2) is for calendar year 2013, and (3) includes the option to extend the contract for a one year period for up to a total of two years; and

WHEREAS, the RFP sought an agency with experience as a firm that has demonstrated a record of providing fiscal and operational management experience for government agencies; and

WHEREAS, the RFP required applicants to (1) have experience working with Family Care or other home and community based waiver programs; (2) have a documented track record with managed care accounting principles, auditing, cost projections, rate setting, refining IT systems, and service and accounting reporting; and (3) indicate certified Disadvantaged Business

Enterprise (DBE) firms have the maximum opportunity to participate in the contract; and

WHEREAS, Andrea & Orendorff, SC submitted a proposal that was scored best in both the presentation of services required as well as pricing; and

WHEREAS, A three-year agreement is the most cost effective and beneficial option for the MCO providing a consistent source for undisturbed Senior Management Services; and

WHEREAS, Andrea & Orendorff, SC is considered a 100% contributor to the Disadvantaged Business Enterprise due to their firm being an approved DBE; and

WHEREAS, a 2013 Professional Services Contract with Andrea & Orendorff, SC for \$932,000 will be funded through rates and fees collected by Milwaukee County Department of Family Care in 2013; and

WHEREAS, now therefore,

BE IT RESOLVED, that the Director, Department of Family Care, is hereby authorized to

Enter into a Professional Services Contract with Andrea & Orendorff, SC for the period of January 1, 2013 through December 31, 2013, total fees paid to contractor shall not exceed \$932,000 during the contract period, and with the option of up to two one-year extensions without a competitive Request for Proposal (RFP) based on satisfactory vendor performance

 BE IT FURTHER RESOLVED, that agreements will be contingent upon County Board authorization of the Department of Family Care continued participation as a Managed Care Organization (MCO) under Family Care for the period January 1, 2013 through December 31, 2013.
