1.02 EMPLOYEE DEFINED

Wherever the term "employee" is used in this Agreement, it shall mean and include only those employees of Milwaukee County within the certified bargaining unit represented by the Union.

1.04 DURATION OF AGREEMENT

- (1) The provisions of this Agreement shall become effective on January 1, 2013 unless otherwise herein provided. Unless otherwise modified or extended by mutual agreement of the parties, this Agreement shall expire on December 31, 2013.
 - (2) The initial bargaining proposals of the County and the Union for a successor agreement shall be exchanged prior to November 1, 2013 at a time mutually agreeable to the parties. Thereafter, negotiations shall be carried on in an expeditious manner and shall continue until all bargainable issues between the parties have been resolved.
 - (3) This timetable is subject to adjustment by mutual agreement of the parties consistent with the progress of negotiations.
