 - A. Approval of this resolution will authorize the abolishment of one position of Administrative Secretary 2-Constituent Services Representative in Org. Unit 1020-Government Relations effective May 1, 2014. Unused salary appropriations would later be transferred in a separate appropriation transfer to Org. Unit 1800-1945-Appropriation for Contingencies.
 - B. The fiscal savings for 2014 of \$41,386 reflects a total of \$46,830 in salary and social security budgeted for the position, less \$5,444 that was spent in 2014 to pay the terminated incumbent. For 2015, the anticipated impact is the full salary and social security costs using the amount appropriated in 2014. This fiscal note reflects only salary and no other benefit costs such as for health insurance or pension benefits.
 - C. The budgetary impacts for the current year would be to transfer approximately \$41,386 in unused expenditures from Org. Unit 1020-Government Affairs to Org. Unit 1800-1945-Appropriation for Contingencies. For the purposes of this fiscal note, this reflects budgetary savings since the position may no longer be filled.
