Increase of \$156,848 in operating expenditures in Org. Unit 2900- Pretrial Services, for the period of March 1, 2014-September 30, 2015 will be offset by an increase in operating revenue from the U.S. Bureau of Justice Assistance (BJA) Adult Drug Court Discretionary Grant #2013-DC-BX-0034 received from BJA on August 29, 2013. This award results in an increase from the original 2014 Org. Unit 2900 approved budget. As a result of RFP #6888, a professional service contract will be executed with JusticePoint in the amount of \$124,766. A professional services contract will also be executed with the University of Milwaukee Wisconsin-Milwaukee Center for Applied Behavioral Research in the amount of \$32,082 for evaluation services. These contracts will be for the period of March 1, 2014-September 30, 2015 with possible extensions as authorized by the Bureau of Justice Assistance.

There is no fiscal impact associated with the requested action.
