Supervisor Theodore Lipscomb, Sr., Chairperson, 1 From the Committee on Judiciary, Safety, and General Services, reporting on: 2 3 4 File No. 14-391 5 (ITEM ) From the Office of the Sheriff, requesting authorization to execute the Fifth 6 7 Amendment to an existing grant with the Wisconsin Department of Transportation for 8 provision of a Freeway Service Team for an additional \$250,000, bringing total grant funding to \$1,503,332 and extending the period from July 1, 2013, to June 30, 2014, by 9 recommending adoption of the following: 10 11 A RESOLUTION 12 13 WHEREAS, the State of Wisconsin Department of Transportation (WisDOT) has 14 authorized the Milwaukee County Sheriff to maintain a Freeway Services Team (FST) to 15 operate on the Milwaukee County freeway system and provide expedited clearance of 16 disabled and crashed vehicles, thereby improving safety and minimizing traffic delays and 17 congestion; and 18 19 WHEREAS, the State of Wisconsin has identified the service area as I-94 from the 20 21 Milwaukee/Racine County line to the Milwaukee/Waukesha County line, I-894 in its entirety, I-43 from downtown Milwaukee to the Milwaukee/Ozaukee County line, I-794 22 between Carferry Drive and the Marquette Interchange, and US 45 from I-94 to the 23 Milwaukee/Waukesha County line; and 24 25 WHEREAS, the Milwaukee County Sheriff's Office will provide an FST to 26 continuously drive the service area, locating, responding to, and clearing minor traffic 27 incidents; and 28 29 WHEREAS, FST shall assist motorists whose vehicles have suffered mechanical 30 failure or have been involved in minor traffic crashes and shall be responsible for clearing 31 the traffic lanes of the highway of automobiles, motorcycles, small trucks, and small non-32 hazardous debris material; and 33 34 WHEREAS, the original grant became effective August 1, 2008, and extended to 35 June 30, 2009, included funding of \$371,000, and there have been four grant amendments 36 through June 30, 2013, with total cumulative funding of \$1,253,332; and 37 38 39 WHEREAS, this amendment to the grant period is for July 1, 2013, through June 30, 2014; and 40 41 WHEREAS, the Milwaukee County Sheriff's Office will bill WisDOT on a monthly 42 basis for deputy sheriff straight time with overhead included at \$59.74 per hour and 43 overtime hours excluding overhead at \$44.00 per hour; and 44
