11 12 13 14	WHEREAS, on April 25, 2013, the Milwaukee County Board authorized Milwaukee County to enter into agreements with six (6) rental car companies (File No. 13-293) for the operation of a rental car concessions at General Mitchell International Airport for a five- year term beginning July 1, 2013, and ending June 30, 2018; and

16 17 18	WHEREAS, the new agreements relocated several of the ready car locations of the individual companies within the ready car area of the parking structure; and
19 20	WHEREAS, in order to provide for a more efficient use of garage space, the County was to remove ramps and fill in the holes creased by ramp removal with the rental car
21 22 23	companies reimbursing the County for the costs of these modifications through a \$1.00 per rental car contract customer facility charge; and
24 25 26	WHEREAS, construction delays prevented the garage modifications from being completed by the inception of the agreement term on July 1, 2013; and
27 28 29	WHEREAS, the rental car companies have also incurred costs related to relocating to their new ready car areas that are not included in the County's costs; and
29 30 31 32	WHEREAS, because of the delays, the rental car companies are requesting that the agreements be extended in order to give them a full five years to amortize their costs; and
33 34 35	WHEREAS, the original commencement date of the agreement was January 1, and the current agreement language states that the rental car companies are to submit an annual audit within ninety (90) days of the close of each calendar year; and
36 37 38 39	WHEREAS, due to the change in the commencement date, the annual audit should be submitted within ninety (90) days of the close of each contract year; and
40 41 42 43	WHEREAS, the Committee on Transportation, Public Works, and Transit, at its meeting on May 7, 2014, recommended adoption of the Department's request (vote 7-0); and

44 WHEREAS, the Committee on Finance, Personnel, and Audit, at its meeting on May 15, 2014, also recommended adoption of the Department's request (vote 8-0); now, 45 46 therefore,
