- 5. Participant hereby agrees to pay its allocated share of the fees as set forth in the Fee Schedule in the Master Agreement, as determined by the Contractor.
- 6. The Participation Agreement shall commence on the effective date set forth below and continue until June 30, 2014.
- 7. All terms and conditions of the Master Agreement shall remain unchanged and in full force and effect.

Addendum to Banking Contract to modify merchant service fees

The attached item is being sent to your office in order to request referral of this matter to the Finance and Audit Committee for consideration at their April 16, 2009 meeting.

This communication is being forwarded in order to (1) authorize the execution of an addendum to the existing Banking Services Contract for the final two-years of the current five-year contracts - until June 1, 2009; and (2) implement the addendum, which would reduce the merchant service fees in that contract.

The current US Bank contract contains provisions for merchant services (credit card usage) that were submitted four years ago. Better rates are now available through the State US Bank contract which contains provisions that make these state merchant services rates available to all local government units in Wisconsin.

The resolution recommends that the County Treasurer execute a contract addendum with US Bank to enact the State of Wisconsin US Bank contract merchant services terms for credit and debit cards (debit, credit, VISA, MasterCard, Discover, etc.) for the remaining term of the Milwaukee County contract - until June 1, 2011 - subject to the approval of the Corporation Counsel and the Office of Community Business Development Partners. This action will institute lower fees (estimated at 0.40 basis points or more) for merchant service transactions for all affected county departments. Given the current estimated payment volumes, this will result in an overall County savings in fee payments of approximately \$10,000 per year.

A RESOLUTION

authorizing the institution of merchant services with US Bank under the favorable terms and conditions of the State banking contract with US Bank by recommending adoption of the following:

WHEREAS, the County Board file No.05-438 authorized the Request for Proposal (RFP) process to receive bids for Milwaukee County's banking services; and,

WHEREAS, in December 2005 an extensive RFP process was undertaken to attract proposals for banking services for Milwaukee County, resulting in a total of five proposals being submitted for the banking deposit services and five proposals for the banking disbursement services.

WHEREAS, the proposals were reviewed by an independent review committee composed of finance personnel from four different county departments outside of the Treasurer's Office. As a result of this RFP process, Milwaukee County awarded its contract for deposit and disbursement banking services to US Bank; and

WHEREAS, the recipient of the contract, US Bank, had the highest CRA (Community Reinvestment Act) rating. US Bank also has in place a supplier diversity program and a strategic sourcing effort to include MBE\DBE firms. US Bank also makes considerable community contributions in the areas of affordable housing, economic opportunity and public service; and

WHEREAS, the current US Bank contract contains provisions for merchant services (credit card usage) that were submitted four years ago and better rates are now available through the State US Bank contract which contains provisions that make these merchant services rates available to all local government units in Wisconsin; and

WHEREAS, the County Treasurer recommends enactment of the State of Wisconsin merchant services pricing program for Milwaukee County - which will result in considerably lower fees for the County for its transactions (estimated at 0.40 basis points or more). This will provide the County with a savings of approximately \$10,000 per year in fees, given the estimated payment volumes; now, therefore,

BE IT RESOLVED, that the Milwaukee County Treasurer is hereby authorized to execute a contract addendum with US Bank to enact the State of Wisconsin Contract merchant services terms for merchant services (debit, credit, VISA, MasterCard, Discover, etc. card use) for the remaining term of the Milwaukee County contract - until June 1, 2011 - subject to the approval of the Corporation Counsel and the Office of Community Business Development Partners.

The County Board F file No.05-438 authorized the Request for Proposal (RFP) process to solicit proposals for banking services. The resultant five-year contract with US BANK for deposit and disbursement banking services was approved by the County Board and commenced on April 1, 2006. It contained provisions for US Bank provison of merchant services (credit and debit card use and fees).

This resolution would modify the provisons for merchant services within the existing County banking services contract for approximately two more years, until June 1, 2011. The modification would override various terms of the Mllwaukee County contract by enacting the provision of the State of Wisconsin agreement with US Bank for Merchant Services that makes available the terms of the State contract to all local government units throughout the state.

This modification will result in an overall reduction of credit card/debit card fees paid by Milwaukee County departments by a total of approximatley \$10,000
