

Amendment No. 2 to the Interagency Agreement (Acct. #133-PRJ54MJ)
Between Milwaukee County Parks and the
Board of Regents of the University of Wisconsin System

By this amendment, Milwaukee County Parks (County), pursuant to the authority vested in the County Committee on Agriculture and Extension Education by sections 59.22(2)(d) and 59.56(3) of the Wisconsin Statutes, and the Board of Regents of the University of Wisconsin System, on behalf of the University of Wisconsin-Extension, Cooperative Extension Division (Extension), agree to amend their existing interagency agreement as follows:

1. Fiscal Period - The term of this amendment is: January 1, 2014 to December 31, 2014.
2. In consideration of the programs that Extension provides to the County under the interagency agreement, for the fiscal period of this amendment, the County agrees to pay Extension \$265,000. The amount of \$265,000 will be invoiced upon full execution of this amendment. 
