Rob Henken, President, Public Policy Forum (PPF), appeared and spoke regarding this item. Mr. Henken delivered an electronic presentation which is attached to this file. He responded to questions from Commissioners and the public.

The Commissioners stopped to consider other items and then resumed discussion of this presentation.

Commissioner Hamilton suggested that the Commission adopt a position on possible public funding of an arena, convention center, and other entities, noting that only parks a) are free and open to the public and b) have secured public support for a sales tax in a referendum.

The Commissioners discussed possibly holding a public hearing regarding public funding of these entities. Commissioner Gurda stated that any public hearing should be structured, not an open-ended conversation. Chairwoman Briscoe began to formulate the public hearing's focus: Should a sales tax for public cultural and entertainment entities be broadened to include parks?

Commissioner Gurda requested time to digest the presentation. He suggested a future agenda item to determine which funding model the Commission

favors, balancing what is good for the community and the parks. Chairwoman Briscoe drew attention to the presentation's final slides, which she finds are critical.

Commissioner Hamilton asked how the Commission could have a voice in discussions of the Cultural and Entertainment Capital Needs Task Force. There was consensus that Chairwoman Briscoe should request a seat on that Task Force.
