- A. The Department of Parks, Recreation and Culture (DPRC) is seeking authorization to execute real estate transactions in the City of Wauwatosa that will accomplish mutual goals of the City and County. Approximately 14 acres of land will be transferred to Milwaukee County to be used for park purposes, approximately 1.3 acres will be transferred to the City of Wauwatosa for use as right-of-way, and approximately 3.2 acres of easements will be granted to the City of Wauwatosa for utility infrastructure needs.
 - B. The DPRC will receive \$250,000 from the City of Wauwatosa for easement and related fees and will expend that amount through capital project WP280-01 – Menomonee River Parkway Reconstruction.
 - C. Increased capital revenue of \$250,000 and increase capital expenditures of \$250,000.
