30 31 32	WHEREAS, Mr. Rivera alleges that his non-promotion and his subsequent supervision by the Accounting Manager was based on illegal discrimination; and
 33 34 35 36 37 38 	WHEREAS, Mr. Rivera claims lost wages, including overtime, for the three years since not being promoted totaling approximately \$65,000 and further claims attorneys' fees against Milwaukee County as a portion of his recovery, currently alleged to be approximately \$10,000; and
 39 40 41 42 43 44 	WHEREAS, Milwaukee County's counsel negotiated a settlement with Rivera and his counsel for a payment by Milwaukee County of back wages to Mr. Rivera in the amount of \$15,000, a payment by the Wisconsin County Mutual to Mr. Rivera's attorneys, The Previant Law Firm S.C., of fees in the amount of \$6,500, and the promotion of Mr. Rivera and his assignment to a vacant Technical Specialist Level IV position at Step 1 of the pay range; now, therefore,
