The Sheriff is requesting approval to execute a Professional Services contract with CenturyLink Public Communications, Inc. to provide a video visitation system for inmates incarcerated in the Milwaukee County Jail. CenturyLink will provide the system at zero cost to Milwaukee County and will maintain and support this system throughout the term of the contract agreement at zero cost. The system utilized by CenturyLink is similar to a telephone system and will allow access to the video visitation system remotely by family and friends of inmates or on-site at the Milwaukee County Jail.

Payment for the system will be derived from a charge to remote users of \$0.65/per minute payable directly to CenturyLink. CenturyLink will not charge for video visitation at 11 designated public stations located at the Milwaukee County Jail.

The contract term with Century Link will be for 24 months commencing on the date of activation of the video visitation system with two one-year renewal options for an additional 3rd and 4th year. The estimated dates of the initial contract term is October 1, 2014 – September 30, 2016.
