REQUEST

Authorization to sell five Tax Deed foreclosed properties back to previous owners.

BACKGROUND

Through the 2013 INREM foreclosure process the Department of Economic Development has been approached by previous owners interested in purchasing back the properties they had lost through foreclosure. After considering all requests, the Department recognizes the benefit for the County to sell back the following properties to the original owners or designated estate for assignment purposes. The price is equal to total outstanding taxes, plus interest, penalties, and an Administrative fee of \$5,000 per property.
