A. The Zoo Director is requesting the authority to enter into a contract with SSA for concessions, catering and novelty operations at the Milwaukee County Zoo for a ten-year period and with the approval of the County Board, the term of the Agreement may be extended for additional five-year terms.

B. For 2015, revenues will be reduced by \$3,665,874 completely offset with expenditure reductions of \$3,665,874 for a zero net tax levy impact to the operating budget. SSA will provide \$3 million in capital improvements for Zoo facilities improvements during the first five years of the contract, which works out to be \$600,000 per year. Most of the improvements will be completed during the first three years for revenue growth. SSA will also provide \$30,000 in marketing support per year for the first five years of the contract for a total of \$150,000.

SSA is projecting that revenues will increase each year of the contract which will also increase the commission revenue paid to the Zoo. For 2016, commission revenues to the Zoo are projected to increase by \$208,647, \$104,898 in 2017, \$82,953 in 2018 and \$78,037 in 2019 for a total accumulated increase in revenues of \$474,535. Additional revenues are also projected for years six through 10 of the contract. Enhanced visitor experience will also increase attendance and return visits, which increase other Zoo revenue accounts. The County and the State will receive additional sales taxes from SSA purchases whereas the County is exempt for those taxes. Additional full-time staff will be hired at the Zoo where additional income taxes will be paid to the State.

The Zoo and the County will also achieve savings by cost avoidance for the following: wage and benefit cost increases, fuel savings, repair and maintenance of equipment, purchasing replacement equipment, reduction in worker compensation claims and risk transfer to SSA, food

liability issues will be transferred to SSA, HR/Ceridian payroll savings, cash handling risk and transfer to SSA, and a reduction in training costs.

- C. The 2015 contract impact is a positive amount of \$630,000. Expenditures and revenues will be reduced by \$3,665,874 for a zero net impact to County's 2015 Budget. The 2016 Budget will be adjusted to reflect the change to a new service model.
- D. The revenue projections were provided by SSA and the projections were reviewed and given a high confidence factor by the consultant that was hired to assist the Zoo in developing the RFP. SSA has proven results with 31 other zoos in 16 different states serving over 25 million guests annually.
