The Personnel Review Board (PRB) hired disadvantaged business attorneys and maintained contracts with County DBE attorneys from 1996 to 2005. After that time, the DBE vendor merged her office with that of the law firm of Gonzalez Saggio and Harlan LLP. This law firm was on the County's DBE list until it was removed due to its size. Although the firm is no longer disadvantaged, it is still a minority enterprise, being minority owned and controlled, having a staff which is diverse and representative, and having a commitment to minority representation in its staffing and operation. The law firm is a federally registered minority enterprise. The PRB has maintained a successful relationship with the law firm for a number of years and would, for the sake of continuity and their ongoing knowledge of the PRB operation, like to continue to retain them. Additionally, the law firm is providing the county with a substantially discounted rate.

Although the PRB has a 0% total, when combined with the other entities that share space, labor, supplies, and materials with the PRB (the Civil Service Commission and Ethics Board), the office as a whole meets the 17% DBE goal, as both the Civil Service Commission and Ethics Board utilize DBE firms. We believe the intent of the MBE/DBE goals for minority representation are being met by this office. For these, reasons, we ask that a waiver be granted to the Personnel Review Board with the understanding that the Ethics Board and Civil Service Commision will utilize MBE/DBE law firms.
