15 16 17 18 19 20	WHEREAS, Section 32.91 of the Milwaukee County Code of General Ordinances (Ordinances) directs the Department of Administrative Services (DAS) to prepare a final comprehensive annual list of capital projects and major repairs identified as completed and/or recommended to be abandoned to the Committee on Finance, Personnel, and Audit; and
21 22 23 24 25	WHEREAS, the final carryovers for 2014 to 2015 being processed by DAS and the Milwaukee County Comptroller include \$3,852,960 in appropriations and \$6,945,595 in related revenues, and \$120,226,272 of capital improvement appropriations including carryovers for the Airport and \$110,810,283 of capital improvement revenues; and
26 27 28	WHEREAS, recommended lapsed operating budget appropriations for capital expenditures and major repairs (8500 accounting series) total \$2,398,206; and
29 30 31 32	WHEREAS, \$1,233,918 of expenditure appropriations and \$907,306 of revenues for the non-airport capital projects is requested to be lapsed as described in attached Schedule B; and
33 34 35	WHEREAS, \$17,440,512 of expenditure appropriations and \$16,254,977 of revenues for the airport capital projects are requested to be lapsed as described in attached Schedule C; and

40 41 42 43 44 45 46	BE IT RESOLVED, the recommended lists of lapsed appropriations for completed/abandoned capital expenditures and major repairs recommended by the Department of Administrative Services (DAS) and the Milwaukee County Comptroller, and approved by the Committee on Finance, Personnel, and Audit are hereby approved; and

- 47 BE IT FURTHER RESOLVED, DAS and the Milwaukee County Comptroller are 48 authorized and directed to make the necessary adjustments to complete the 49 lapsing/carryover process and, if necessary, submit a final report for the June 2015 50 cycle of the Committee on Finance, Personnel, and Audit; and

- 52 BE IT FURTHER RESOLVED, a cash deficit amount of \$210,732 from lapsed 53 capital projects is lapsed to the general fund and \$537,345 in surplus bonds which are 54 not eligible to be included in the determination of net surplus, shall be deposited in the 55 Debt Service Reserve; and

- 57 BE IT FURTHER RESOLVED, a surplus cash amount of \$1,184,449 and a 58 surplus bond amount of \$1,086 from airport capital projects are lapsed to the 59 appropriate airport account; and

61 BE IT FURTHER RESOLVED, DAS and the Office of the Comptroller are 62 authorized and directed to perform an administrative appropriation transfer to reverse 63 the temporary carryover transfers approved by the Milwaukee County Board of 64 Supervisors in January 2015 and March 2015.
