

SECOND AMENDMENT TO
PROFESSIONAL SERVICE CONTRACT

Milwaukee County, a Wisconsin municipal body corporate (hereinafter called "County"), represented by Paul Bargren, Corporation Counsel, and von Briesen & Roper, s.c. (hereinafter called "Contractor") previously entered into a contract for professional service on September 29, 2014 (the "Contract") and amended the Contract on December 2, 2014. The parties hereby agree to further amend the Contract, as follows:

SCOPE OF SERVICES: The Contract is hereby amended to include legal service for defending any appeal of the judgment obtained in circuit court that establishes the County's title and rights to the Transit Center property, and to include legal service for any further related proceedings required in circuit court, in the time and manner approved by Corporation Counsel.

COMPENSATION BILLING: The Contract is hereby amended to provide that the total compensation to Contractor for services performed under the Agreement shall not exceed TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) unless agreed to by County in writing.

The foregoing amendments are contingent on County Board review and active or passive approval. Except as set forth above, all provisions of the Agreement between the parties, as amended, remain in force and effect.




