offender residency restriction ordinances are pre-empted by state law. His understanding is that the state departments involved are intending to move forward with placement accordingly.

He received notice of this order from an Assistant Milwaukee County City Attorney, and sent out a notice to all municipal attorneys for cities and villages suggesting a meeting to discuss this matter. A meeting took place with a few general consensus conclusions. The thought was to hire an experienced municipal law firm to coordinate any further actions, with equal sharing costs. The alternative was to get assistance from the Milwaukee City Attorney. The Milwaukee City Attorney has offered to take the lead through his office on any necessary legal actions. An oversight committee was formed, comprised of four lawyers. Letters were submitted to the court from all the municipal attorneys. A majority requested the court to 'stay' and then reconsider and vacate the order which says that all the local ordinances are pre-empted. As of this morning, the Circuit Court on April 9<sup>th</sup> issued an order denying the request from the City of Milwaukee that nearly all the other municipalities joined in with.

The next discussion will be to consider an application for a supervisory writ with the Court of Appeals. Various communications to the court made it clear that every sex offender residency restriction ordinance adopted by the 19 municipalities is unique to that municipality. Those communications included a map of protected areas.

Attorney Wesolowski cited a recent state placement of an individual upon release across the street from a school. That is the concern of all municipalities.

## VI. Review the contracts of shared services between Milwaukee County and the municipalities (recurring item)

1. City of Greenfield Agreement regarding Kulwicki Park
Mayor Neitzke said the proposed agreement was distributed by email to all from
Mr. Peterson. At the last meeting, Mayor Neitzke spoke at length about the
merits of this agreement. He hopes this Council supports it.

Mayor Neitzke spoke about one legal concern regarding the environmental liability within the agreement. That issue remains to be worked out between the attorneys before the agreement goes to the County Board. This doesn't affect the intent or obligations of the parties, and the financial remuneration by the City to the County. He asks that the agreement be adopted by this body, consistent with Act 14, leaving the environmental liability subject to further review.

- 3. EMS (President Brunner, Mayor Hohenfeldt). Mayor Hohenfeldt said at the last meeting, Christine Westrich, Milwaukee County OEM, gave a great presentation on civil liberties vs civil protections. She spoke about safe facilitation and the public's right to protest. He highly recommends this presentation.

Mayor Hohenfeldt gave an update on quality assurance. They are looking at the different statistics they have on cardiac events, strokes, and heart attacks. It was found that Milwaukee County, with the EMS program, has better numbers than the national numbers.

The EMS Council has asked for help from municipalities. If you are having special events, a race or walk, get in touch with EMS. They would like to be aware of special events ahead of time, in case there is a medical emergency.

The lights and sirens policy was discussed. Greenfield, Hales Corners and Franklin have been pro-active in testing of responding to non-emergencies with no red lights and sirens for their ALS and BLS responses. That has been going well, and the information is being monitored. The EMS Council is still working with private ambulance firms that have had problems going through some communities in the past. That issue is still under consideration at one of the subcommittees.
