13 14 15 16 17 18 19	WHEREAS, currently G4S Secure Solutions (USA) Inc., provides transportation services to the Milwaukee County Office of the Sheriff for Milwaukee County inmates between the Milwaukee County Jail, House of Correction (HOC), Vel Phillips Juvenile Justice Center, all State and County institutions, United States Marshal's, medical appointments, and any other transport of inmates that may be needed; and
20 21 22 23 24 25	WHEREAS, G4S Secure Solutions (USA) Inc., currently provides approximately 34,200 inmate transports statewide per year, approximately 395,000 State miles traveled per year, and approximately 21,000 inmates moved between the Milwaukee County Jail and the HOC per year using their own vehicles and providing their own staff; and
26 27	WHEREAS, the current contract with G4S Secure Solutions (USA) Inc., expires October 3, 2015; and
28 29 30 31 32	WHEREAS, in June of 2015 a Request for Proposals (#7024) was issued by the Milwaukee County Office of the Sheriff to provide inmate transportation services for the Sheriff with responses due on July 22, 2015; and
33 34 35	WHEREAS, two vendors submitted responses/bids and G4S Secure Solutions (USA) Inc., was scored the highest and selected by the evaluation committee based upon experience, financial condition, scope of operations, and detailed response; and
